During this past year, Ross Township provided additional funding, which allowed us to repair the pump on Tanker 11. The repair cost was \$5,100.00. Their generosity helped ease the strain on our budget. Thank you to the Ross Township Trustees, Fiscal Officer, and the residents of Ross Township. It is always a pleasure to work with you and I appreciate your support.

FIRE PREVENTION

Kyle Miller, Assistant Chief, is a full-time employee hired to help ease the burden of our volunteers. One of his many duties includes fire inspections which are instrumental to fire prevention. These inspections are performed annually on all businesses. In fact, Kyle made 266 inspections in 2008.

We review blue prints for new construction and upgrades to existing structures; i.e., multifamily homes, industrial, and commercial facilities. Inspections are done on new construction to ensure the most current safety standards are in place. In older buildings, we look for fire and life safety hazards. To Kyle and other members who have assisted with inspections, thanks. The cost of prevention comes with a price and at times may seem to be an inconvenience to the owners. I receive several calls per year in reference to insurance ratings. Here's information regarding our ISO inspection from 2006.

ISO INSPECTION 2006

In May of 2006, the Insurance Services Office (ISO) performed a Public Protection Classification (PPC) survey. The areas involved in the survey were the Village of Cedarville, Cedarville Township, and Ross Township. Each area is graded independently and a number from 1-10 is assigned to that area. In some cases, usually outside a municipality, areas may be assigned multiple numbers.

THE RESULTS

WHAT DOES THIS MEAN?

The lower your Classification number is the better rate for your insurance premium. The Village remained the same, a Class 5. We are only lacking 2.57 points to get to a Class 4. Once the 12-inch water main loop is completed to the north end of town, our water flows should improve. We may request a re-grade to see if we can improve our classification, depending on the hydrant flows.

Cedarville Township was a 5/8/9 and is now a 3/8B. The 3 is for homes outside the Village limits and within 1,000 feet of a fire hydrant and less than 1.5 miles from the fire station. The 8B is for homes greater than 1,000 feet from a hydrant and less than 5 miles from the fire station. The classification change is a result of the ability to carry 4,000 gallons or more of water on our initial response. This contributes to the decrease from a rating of 9 to 8B, which should provide a small savings in your insurance premiums.

Ross Township received a classification of 8B/10. The 8B is for the amount of water, the 10 is for homes with a travel distance greater than 5 miles from the fire station.

HOW DOES THIS COMPARE?

CEDARVILLE UNIVERSITY EMERGENCY MEDICAL SERVICES

This ambulance service assists us with coverage to Cedarville University. They also provide us with back-up services when needed. It is operated by state certified EMS personnel that are students at the University and volunteer their time. During this past year, the University students responded to nearly 100 calls for help. Thanks to CU EMS Chief Jeff Whitacre, your dedicated staff, and Cedarville University for the service you provide.

ASSISTANT CHIEF KYLE MILLER & CHIEF SCOTT BALDWIN

As the two-full time employees for the fire department, I thought I would share our man hours for 2008. Kyle Miller worked 314 days and a total of 2,458 hours. I worked 335 days and 2,946 hours. Thanks to Kyle and his family, for your commitment, leadership, and dedication to Cedarville Township and the Cedarville Township Fire Department.

COMMAND 13

In 2008 we replaced a 1983 Chevy pickup truck with a new 2008 Ford F-150 pickup truck. Cost for the entire project including emergency equipment was \$19,978.00.

NEW MEETING ROOM AND KITCHEN

Our meeting room and kitchen were remodeled with new carpet, paint, floor tile, audiovisual equipment, cabinets, lighting, ceiling grid, and appliances. The total cost of the project was a little over \$42,000.00. This was a cooperative effort between the Township and the Cedarville Firemen's Association. Brentwood Builders of Cedarville was contracted to do the work and did an outstanding job.

The Association provided new appliances, audiovisual equipment, window blinds, and funds for the project, totaling \$12,966.60.

CEDARVILLE FIREMEN'S ASSOCIATION

Along with the nearly \$13,000.00 for the meeting room and kitchen remodel, the Association made many other purchases to help the fire department. The fire department budget could not afford these projects so the Association was gracious enough to make some much needed purchases. Some of the items were: (2) new chainsaws, \$2,948.00; (2) new circular saws, \$2,747.80; A new sign in front of the firehouse, \$2,920.26; Computer equipment, \$548.99; Rescue helmets, \$289.74; CPR manikins, \$1,291.88; Stryker ambulance cots, \$7,709.44; Public relations, \$138.43; and Awards Banquet and personnel recognition, \$2,770.73. These purchases totaled \$34,449.44. Purchases for office supplies, cleaning equipment, food for meetings and trainings, and other odds and ends were not included in the purchases made by the Association. Thanks to the Association and its members for their great financial support!

WINDSTORM OF SEPTEMBER 14, 2008

By 1pm in the afternoon the calls started coming in: power lines down, trees into houses, roads blocked by falling debris, arcing power lines, residents without power needing medical attention, some patients transported to hospitals, the next 24 hours were almost nonstop.

Our equipment and personnel were dispatched to calls in all areas of our jurisdiction. We received help from lots of people, helping with debris removal, cutting fallen trees and brush, and opening up roadways for emergency equipment access.

Our fire station was open as our Emergency Operations Center (EOC) and in contact with the County EOC. We dispatched for the eastern part of Greene County due to problems with the Communications Center and the Greene County radio system.

We responded to over 70 calls in 24 hours. In the days that followed, water was distributed at the fire station, as well as water to livestock. Generators were in use and many areas and residents received help to fulfill some of their needs. We were in contact with DP&L and continued to request their assistance to restore power to our area.

The affects of this storm will be felt for a long time, but the first 7 days were the worst. The cost as a result of the storm to a budget that was already stressed has created a major challenge with our funds. We have made application to the Federal Emergency Management Agency to help recoup some of our costs. With former President George W. Bush declaring our area as a Federal Disaster Area, we should be able to recoup approximately \$12,000.00.

As in the past, I have seen the people of Cedarville and Cedarville Township join together to address these difficult situations. The tornado of 1974 and others over the years, like the blizzards in 1977, 1978, ice storms in the 1980's, fires, neighbors with medical problems and just about any other problem you can imagine, the people in our area are heroes. Neighbors helping neighbors, banning together to make things better than before: I for one am proud to call Cedarville home.

2009 OUTLOOK

As we move into 2009, there are several projects underway. We are continually working on staffing issues. As mandatory training requirements continue to increase and with our call load, it is becoming more difficult to recruit volunteers. As our membership continues to decrease, more is required from our members. When the University is in session, we can always count on our student members to help out. During holidays and when the University is out of session, staffing becomes a critical issue. During this time, our membership is reduced to 21. Of those 21, some are working while others are on vacation, which limits their availability. This requires us to depend on automatic mutual aid from other departments that surround our jurisdiction. I am grateful for good neighbors. Thanks to those Chiefs and their staffs for responding to assist us.

The Firemen's Association is actively seeking new members. A recruit committee has been established and seeking new members to volunteer and help our community. Application for membership is obtained through the Firemen's Association, while appointment to the Fire Department is by the Chief.

The increased cost of operations is always a concern. Fortunately by being good stewards of your tax dollars, we are able to manage those costs. However, sometime in the near future, regardless of how frugal we are with managing costs and purchases, we may need to go to the taxpayers and ask for help. This will only be done as a last resort. Our goal is to maintain the level of service which you deserve.

Our 1992 ambulance has been replaced with a new Ford/Horton Ambulance and was delivered February 9th, 2009. The cost for the new ambulance is \$160,514.62. It will be

purchased through a lease purchase agreement over the next 5 years.

I would like to thank our members and their families for all they do and the sacrifices they make to provide such great service. I would also like to thank Kevin Dougherty, President, and the Executive Officers of the Cedarville Firemen's Association. It was an honor and pleasure to work with you.

A special thanks to Dr. Lynn Bailey and Dr. Steve Dixon, our Medical Directors. As EMS providers, they allow us to operate under their license for prehospital protocols. Also, I would like to thank the staffs of the area hospitals for their quick response and care of our patients and our EMS crews.

In conclusion, to the residents of Cedarville and Cedarville Township, thanks for your help and support. It is a great honor to serve as your Fire Chief in this wonderful community. 
